





## **Communities Against Terrorism** Potential Indicators of Terrorist Activities Related to Construction Sites

What Should I Consider Suspicious?	What Should I Do?
<ul> <li>Removal or altering of survey stakes on a construction site.</li> <li>Anyone inquiring about security at a construction area.</li> <li>Surveillance of the site by unknown individuals.</li> <li>Environmental and/or antigovernment slogans, banners, or signs at the site or in the nearby area that threaten or imply violence.</li> <li>Group identifiers or warning signs left on the site.</li> <li>People entering a construction site after work hours.</li> <li>Warnings or threats sent to construction companies.</li> <li>Unscheduled deliveries of materials/equipment.</li> <li>Items found on-site that do not belong or are not a part of the site materials.</li> <li>Vandalism at similar sites.</li> <li>Thefts of hazardous materials.</li> <li>Vandalism at the site, including window breakage, slashed tires, spray-painting, sand/sugar in fuel tanks, cutting of fuel and brake lines, and/or glued locks.</li> <li>Arson at buildings under construction, work sheds, or any kind of equipment, including trucks, bulldozers, and cranes.</li> <li>Following a crime on-site, the discovery of discarded clothing, shoes/boots, tools, or spray-paint cans along roads and paths near the site.</li> </ul>	<ul> <li>Maintain your construction sites.</li> <li>Secure potentially dangerous or hazardous products.</li> <li>Clean the site regularly.</li> <li>Watch for people and actions that are out of place.</li> <li>Know what material and equipment should be onsite.</li> <li>Know what subcontractors and workers should be on-site.</li> <li>Do not leave the site unattended for long periods.</li> <li>Require all subcontractors to be licensed and insured.</li> <li>If something seems wrong, notify law enforcement authorities.</li> <li>Do not jeopardize your safety or the safety of others.</li> <li>Preventing terrorism is a community effort. By learning what to look for, you can make a positive contribution in the fight against terrorism. The partnership between the community and law enforcement is essential to the success of anti-terrorism efforts.</li> <li>Some of the activities, taken individually, could be innocent and must be examined by law enforcement professionals in a larger context to determine whether there is a basis to investigate. The activities outlined on this handout are by no means all-inclusive but have been compiled from a review of terrorist events over several years.</li> </ul>
