DEFINITIONS

Chief - Highest; as in rank or **Office**. esp. Administration of His own **Office** or Private Affairs, or **Trust**.

Identification - Anything by which a person, or thing, can be identified.

Credentials - A document that is **Official** proof, or **Certification**, of a person's position, **Office**, **Authority**, etc.

Officer - A person in a **position of Authority** such as an Executor for a Trust, Creditor, or Authority of the People.

Citizen - A native, inhabitant, or aboriginal esp. a freeman of a nation, town, city or self-governance-self authority.

Cooperation - The association of a number of people in an enterprise for **mutual Benefits** or other **Consideration**.

Beneficiary - A person for whose Benefit a Trust has been created. esp. **Public Trust – Citizens Estate Benefits**.

Trustee - A person to whom another's property is entrusted. esp. **Public Servant** entrusted to **Serve & Protect Estate**.

Estate - Assets, properties, accounts, titles, licenses; certificates and liabilities of a **dead or bankrupt person or entity**.

Person - Natural Man, Individual, legal Entity, or **Corporation** having certain legal rights. Also See: "Juristic Person"

Juristic Person - A **non-living** (dead) **entity** regarded by **law** to have the status of **personhood**. Also See: "person".

Corporation - **Legal entity or Artificial-Juristic Person** that exists **independent** and **separate** of the Natural man.

Executive - Carrying out duties, functions, administrate laws, administer a Trust or **Bankruptcy**.

Executor - One who carries something out or 'executes' the orders, or duties, of the Trust or a **Bankruptcy**.

Office - A function, or Duty, A **position of Authority** or Trust. Or **Power Of Attorney** or **Creditor** of a **Bankruptcy**.

Official - Of or holding an Office, or Position of Authority. esp. **Attorney in Fact**. Or **Creditor** for a **Bankruptcy**.

Domestic - A **servant** or being subject of another such as a country; state, **creditor**, master or **owner**.

Offer - To present for **Consideration**. esp. Offer to **Co-Operate** for a specific, **Beneficial, Consideration**.

Consideration - A value given or done in exchange for something of value given or done by another, in Contract.

Contract - An agreement, **Cooperation**, or **Trust** between two or more people to do something **enforceable by Law**.

Perform - To carry out; meet the requirements of; fulfill (a Promise, Command, Trustee Duty, Contract, etc.)

Creditor - A person who extends credit or to whom money, debt, **service**, or **Benefit**; is **owed**. Also see: **Bankrupt**.

Bank Note - A type of negotiable instrument known as a **Promissory Note** or Debt Owed. Also see: **Bankrupt**.

Promissory Note - An **unconditional promise to pay** (owe) a sum of money **IE: lawful money**. Also see: **Bankrupt**.

Obligation of USA - To **redeem** federal reserve bank notes, on demand at **treasury department**, for **Lawful Money**.
